

Fifty-per-cent of all qualified voters must vote in order that the election be valid.

Each voter shall have one vote in the Hall Election excepting Oppidan voters who have two but may not register btoh votes in favour of one candidate. Each voter has five votes for general representatives and one presidential vote. Not all votes need necessarily be exercised. Not more that one vote per candidate may be cast by a voter in the general election.

You are eligible to vote if you have paid your amenities and have been registered at Rhodes for at least two terms.

Spoilt papers are not counted, but blank papers are classed as votes cast. 'Spoilt' means papers with illegible signatures, votes cast by proxy, two or more papers from the same voter, papers where one voter has cast more than one vote for the same candidate, or any papers with more votes than each voter possesses.

Objections against any eletion must be handed to the scrutineers within 24 hours of the close of the elections.


Thirdly I believe that students should be free to choose whether or not they would like to live in residence.


If elected I shall promote the following issues:

In universities today, there is the constant problem of the Administration and the students being two separate entities. Therefore, a coordinating body is needed to mediate between these two entities. I see this as being the primary function of the SRC. Through the SRC the students can express their wishes and the SRC can attempt to have these wishes communicated to the University dministration. Conversely, a deeper understanding of administration and its problems can be developed in the students through the SRC. Although the SRC. may not visibly achieve much, it does play a vital role in the deciding of many small issueswhich do not appear to merit much publicity, but which clearly affect student life. An example of this would be the question of price rises in Kaif.

A second function of the SRC and one which is particularly relevant today is that of Inter-university contact It is all too easy in the closed university system for the university to become isolated. This has special relevance to us here in Grahamstown. Thodes can only benefit from an exchange of ideas with students from other universities. Furthermore, I believe that this contact should extec not only to the English-speaking universities but also to the Afrikaans-speaking universities and the Black universities. I propose: 1. To enhance the status of the SRC so that as the central responsible body of Senior Students, experienced in student affairs and representative of this Campus, it will work for increased participation in Governing Bodies - eg Faculty Councils. 2. To work for and expect the change promised for 1977 in the Residence system within a relationship of mutual respect, trust and co-operation between the Administration and the SRC. In my belief this change will come in 1977, as has been promised, and responsible cooperation with the Administration will facilitate this.

3. Abolition of the Smuts Residence System.

4. External: Rhodes breaks with NUSAS at the end of September. This is an admirable opportunity to reevaluate our role as a student body in South Africa. What organisation do we require for our needs? Do we require an external organisation at all? If so, which? If elected, as an independent individual with no affiliation to any other student organisation, I propose to answer these questions in the interest of Rhodes Students.
