

**SETTLEMENT AGREEMENT**

**1. PREAMBLE:**

This agreement records the terms and conditions reached following negotiations held between the company and the union, as set out herein below:

**2. COMMENCEMENT DATE AND DURATION:**

The provisions of this agreement, unless specified differently, shall be effective from 01 October 2013 till 30 September 2014.

**3. WAGE INCREASE:**


Parties agree that an increase of 6.00% across the board will be given to all employees within the bargaining unit.


**4. SHIFT ALLOWANCE:**

Parties agree that the status quo remains on this point. [current shift allowance 2.5% morning; 5% afternoon; 10% night]

5. HEAVY DUTY ALLOWANCE

Heavy duty allowance is improved to R20.00 per week for bags weighing 50kg and above having to be carried by employees for a period.

6. OVERTIME MEAL ALLOWANCE

Parties agree that a meal allowance of R20 will be provided to employees who are requested to work overtime at short notice.

7. TRANSPORT ALLOWANCE

Matter to be discussed further at National Working Forum

8. GRADING

Parties agree that further engagement is needed and the matter is thus deferred to the NWF.

9. PRECARIOUS EMPLOYMENT

Parties note and agree on the work being done to date on insourcing and filling of positions permanently, but will engage further on the conditions for insourcing (qualifications, criminal record) for temporary employees currently working in the business at the National Working Forum.

10. SILO/BIN ALLOWANCE


Parties agree on a payment of R50 per day for a minimum of 3 hours worked in a silo/bin.

11. LONG SERVICE AWARD


Parties agree on the status quo to remain and the matter to be discussed further in the NWF. The union notes the company's proposal of improving the voucher by R100.

12. CONSOLIDATION OF PREVIOUS AGREEMENTS


All previous agreements to be consolidated into one comprehensive document and the draft document to be circulated before the next sitting of the NWF.


**13. SETTLEMENT**




