## CAPE TOWN TALKS ABOUT SEX WORKERS!

On Monday 25 September, as part of the One City Festival, the Black Arts Collective hosted a debate about sex work. Natasha from SWEAT spoke about the why the government should decriminalize sex work. Khadija Magardie, a journalist from the Mail and Guardian newspaper, sent a speech talking about how sex work should be abolished by changing the law to make the clients criminals, so they can be arrested for buying sex from sex workers. Members of the public came to the debate, and talked about their feelings about sex work, and asked questions and gave comments. Generally most people were supportive of the fact that sex workers deserve human rights, even if they didn't like the idea that people sell sex for a living.

The city is starting to talk about sex work and sex workers, which is very exciting. It is a chance for SWEAT to talk about the realities of the industry, and to break down some of the stereotypes that many members of the public have about sex workers and sex work. One element that is missing from these discussions is the voices of sex workers themselves. SWEAT points out that it is very difficult for sex workers to talk publicly because of the stigmatization they suffer, and because sex work is still illegal. If you are interested in talking to the public about your experiences and opinions, please contact SWEAT and let us know, so that next time there is a chance to speak to the public we can invite you along.

## CLOSURE OF ILLEGAL GAMBLING ESTABLISHMENTS

On 22 August 2000, four illegal casinos in Sea Point were closed. The owners and personnel can be criminally charged and risk being sentenced to a maximum fine of R 2 million or imprisoned of 10 years. Patrons of the respective casinos who were on the premises at the time of their closure were each given the option of paying an admission of guilt fine of R 300. The gamblers who pay these fines will now have criminal records.

The Western Cape Gambling and Racing Board, whose aims are to establish the legal gambling industry in the Western Cape and to regulate the gambling and racing industry to ensure that it would be administered honestly and transparently and to ensure that the interests of the citizens of the Western Cape are protected, is determined to continue tracking down and closing illegal gambling establishments with the Director of Public Prosecutions and the South African Police Services. The Board believes that unlawful gambling establishments do not pay tax and are often linked with other forms of crime and social evils including racketeering, money laundering, prostitution and drug-dealing.

This action takes place on the eve of the opening of the new legal casino in Goodwood in November this year. The Tygerberg Municipality is expecting to see a change in the patterns of sex work in the area, with an increased number of sex workers offering their services close to the casino.

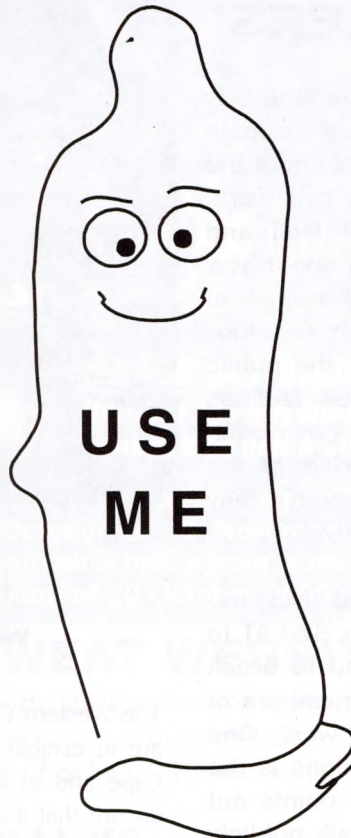
### Anonymous Poem

### "Sex in the Mother City" banned for further viewing

Some of you may have watched a pro-  
gramme called "Sex in the Mother City"  
in July this year. The programme looked  
at the different kinds of sex for sale in  
Cape Town, both on the streets and  
indoors.

SWEAT has heard that the documen-  
tary has been banned for further view-  
ing. This means that it may not be  
broadcast on television in South Africa  
again.

### Keep Business Respectable!

Remember to think about the residents  
in areas where you are working. We  
often get complaints about girls who  
flash, throw used condoms in people's  
gardens and make a lot of noise late at  
night.

The less you hassle the people living in  
your area, the less the chances are that  
you will be arrested.

If you want to have your voice heard,  
remember that you have a right to  
attend meetings in the communities  
where you work. The Community  
Policing Forums are one place you can  
get involved. Go to the meetings as a  
group and make your voices heard!

### ***Increased arrests of street sex workers in Goodwood***

We have received a lot of reports of regular arresting of sex workers along Voortrekker Road in Goodwood. Sex workers are being charged with "soliciting or acting in such a way as to lead to soliciting". This is a municipal by-law, which applies only in the Tygerberg area.

**SWEAT** has tried to find out whether there is anything that can be done to stop the arrests. Unfortunately the arrests are legal and the police say they are being forced to take action because of complaints from residents in the area. This means that as long as law enforcement follow the correct arrest and detention procedures, the arrests can take place.

**SWEAT** would like to encourage sex workers who are arrested to appear in court on their court dates. When you go to court, it is up to law enforcement to prove to the court that you were arrested while you were working. The fact that you are known to be a sex worker to law enforcement is not enough reason for them to arrest you. So the magistrate can't force you to pay the fine unless it can be proved that you were working at the time of your arrest. If you were just walking down the street or coming out of a shop on personal business, you are not guilty of any offense.

### ***Tygerberg Municipality considers red light district***

Good news for those applying for business licenses in the Tygerberg area is that your license can't be refused on the grounds of morality. This means that your application for a license in a business area can only be turned down if you do not pass a health inspection or if the applicant is not suitable to operate a business.



The Tygerberg Municipality is reported to looking into the possibility of setting up a specific area, which would be demarcated for the sex industry. This would mean that something similar to a red light district could be established. Many residents in the area are opposed to the idea. The matter is still under discussion.

### **INTERDICT GRANTED**

On Friday, 27 October 2000, the Cape High Court granted an urgent interdict to prevent the owner of two Wynberg escort agencies from among other things, conducting, carrying on or being interested in the business of a massage parlour, escort agency or brothel.

The order was sought following complaints that the owner was violating the human rights of workers



by among other things forcing them to work for 18 hours a day, restricting their freedom of movement and association and for being in contempt of a court for violating material conditions of a previous court order that was granted against her in June last year, by continuing to lock up workers against their will and by threatening them.

The interdict, obtained by the Women's Legal Centre on behalf of **SWEAT**, will be made final in November unless the owner can prove that she was not in contempt of court.



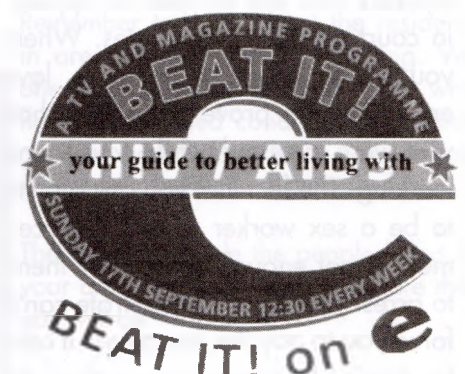
## THANKS
