At the meeting held by the Parties on 6 August 2013 it was agreed by the Parties that:

1. WAGE PARITY AND WAGES INCREASE

1.1 WAGE PARITY

The above has been agreed with effect the 1 July 2013:-

The principle of equal pay for equal work will apply within Entyce and Snackworks where employees will be paid at the higher rate and where applicable, "ring-fencing" will apply.

LSS wages to be align to the Median and where applicable, "ring-fencing " will apply.

A Detailed schedule on wage rates to be attached to agreement on finalization.

1.2 WAGE INCREASE

All basic wages will be increased by 8% (eight percent) with effect from 1 July 2013 after parity has been applied.

2. CONSOLIDATION OF SUBSTANTIVE AGREEMENT

A team consisting of Union Representatives and Management Representatives will draw up a consolidated document by end October 2013





3. LONG SERVICE AWARDS

Long Service Awards have been revised as follows:-

25 Years	R5000-00 (After Tax)

4. EDUCATIONAL / EMERGENCY ASSISTANCE

A loan of R3000-00 per employee per annum may be granted to employees for the use of Educational and/or Emergency Assistance upon proof of proclaimed disaster.

The Monthly Hamper will remain at a cost of R100-00 for 16 items.


7. OTHER CONDITIONS
